LDPOA General Membership Meeting Minutes

The meeting of the Lake Dalecarlia Property Owners Association was held on April 19, 2010. The meeting was called to order at 7:35 P.M. by President Martha Coakley. Pledge of Allegiance was said. Board Members, including Martha Coakley [President], Doyne Cole [Vice Pres.], Geane Anderson [Treas.], Jim Jacobson [Trustee], Mark Torphy [Trustee], Kelly Steur [Trustee], and Section Reps, Norm Bird, Mike Haviland, Tove Roe, and Judy Wolff, plus nine [9] general members and one [1] guest were in attendance.

A motion was made by Doyne Cole to approve the Minutes of the March, 2010, seconded by Judy Wolff. Approved.

Geane Anderson presented the financial report. Balance as of April 1, 2010, \$58,849.08. TOTAL INCOME for period ending April 1, 2010, \$5,235.39: TOTAL EXPENSES, \$4,693 plus \$27,774 [transferred to CD]; NET INCOME {\$27,231.61}. Geane Anderson reported a Restoration Account balance of \$93,443.15 [3/31/10].

A motion was made by Doyne Cole to accept the financial Report for audit, seconded by Judy Wolff. Approved.

In the absence of Bridget Gruzdis, Martha reported there are four [4] confirmed rentals.

Clean up day was a big success. Mike Haviland and helpers repaired all the fencing. Gene Souther suggested the parking blocks should be secured with rebar. Judy Wolff and son placed lights on the railing of steps leading to the lower parking lot. The lights are on a dawn to dusk timer. The Women's Club were thanked for providing a very delicious lunch.

Because Jack Hawkins volunteered his time to enclose and secure the hall storage area, the cost was kept at a minimum. A big "thanks" to Jack.

Martha suggested a Mail Box Beautification effort to encourage community improvement. Discussion followed.

Martha expressed special "thanks" to Tree Care, Lowell, for their donation of mulch for area around the POA building, to Bill Allen for using his tractor to spread the mulch and to Greg Janko for the removal of a tree stump on POA outlot.

Membership Report: 489 paid 2010 assess-

ments, 70 unpaid: 32 liens, 5 in foreclosure and 0 bankruptcy.

Norm Bird reported the fish stocking took place the end of March. Fishermen have reported that fishing is very good this year. Martha reported Dan Gardner from the Lake County Assessor's Office has assured her the Poer Farm drainage problem will be completed before planting season. Sherry and Larry Bright were thanked for being instrumental in ordering the sand for the East Beach and South Lake View Beach. Bill Allen again volunteered to move the sand from the road down to the beach area. Thanks Bill!

Mark Torphy asked that an article be put in the next newsletter for volunteers to erect the playground equipment on May 15, 2010, rain date, May 22, 2010. Since the meeting, the set up date has been changed to Saturday, May 22, 2010. Mark asked that pavilion information be deferred until next meeting.

Stan Lee reported seventy-eight [78] persons have ordered seventy-five [75] motorized stickers, fifty-two [52], non-motorized, five [5] keys, and one [1] expedited fee.

Tove Roe was able to get two new signs, one for each beach, with rules listed, for \$35 each.

Doyne and Mike will be placing the buoys in lake.

Special "thanks" for the good job Stan Lee and Ginny Feyes are doing with boat stickers.

Norm Bird reported there is a downed tree across creek near 1096 North Lakeview. There, also, is a distressed tree on an out lot next to 315/318 W.Lakeview Drive. Mike Haviland will contact someone for estimates on what needs to be done with these trees.

Judy Wolff reported five residents have signed up for the garage sale June 17th. Mike is asking for help and donations from the community for sale located at the POA Building. He has designated profits to be used for a fun event for the Lake Dale Fire Department, possibly a pizza party, dance and DJ.

OLD BUSINESS

Treatment Plant Update

Jim Maurer reported that the UV system was started up and is functioning. EColi testing has been taking place for 2 weeks and the effluent has passed. The propane tank was relocated and the generator was started up successfully. The existing tank has been sandblasted and the inner tank was painted. The diffusers and piping still need to be installed. The catwalk has been installed and the stairs. Most piping between the tanks is installed. The new blower was returned because the fiberglass enclosure was cracked. We are anticipating the new blower to return soon. Jim presented pay request number 10 from Gerig-Ottenweller.

Motion by Virginia Feyes to approve pay request number 10 from

Gerig-Ottenweller subject to receipt of signed documents and waiver of lien.

Second by Jim Teske. Questions or Corrections? No. Motion approved.

Nicole Walkowiak asked if we need to update IDEM with a new anticipated completion date. Jim stated that he will prepare a letter to be submitted with a mid-May completion date.

Jim presented a list of add-on's to the project, including additional driveway on SE side, fencing revisions, farm gate at the entrance, stainless steel bar grate on outfall, final grading. All items total \$7445.
 Motion by Jim Teske to approve all add-on's as presented.
 Seconded by Judy Wolff. Questions or Corrections? No. Motion approved.

Jim addressed the issue of noise coming from the treatment plant. The engineer and contractor are currently working on correcting this issue. The catwalk is vibrating and rattling because of the air piping. This can not be fixed until the old tank is completed. Mufflers will be used for noise control.

159th Meter Project Update OCRA grant possibility

Nicole Walkowiak reported that she attended a grant seminar and again spoke with Gerry White regarding the grant possibility. Nicole has also contacted a grant writer who put us in touch with an income survey specialist. Nicole has met with both and the income survey will be starting soon. Grant applications are due in July. Nicole recommended that the board include the meter to be automated with data sent back to the office and also an automated rain gauge. The board also decided to add an automated interconnection at Main Street for pressure system flow to go to the treatment plant in case of heavy rainfall. This connection will be one way only and the Town of Cedar Lake will also have a key on a double locking system. This will be engineered once we find out if we are eligible for the grant.

Motion by Virginia Feyes to include the automated meter and rain gauge and the interconnection on the grant application.
 Seconded by Judy Wolff. Questions or Corrections? No. Motion approved.

Watercraft Operating and Registration Information

OPERATING SAFETY – For the safety of all persons on the lake please remember to:

- Travel only in a counter-clockwise direction;
- Observe the No Wake/5mph limit at ALL times in any channel and in the main lake between 7pm and 10am daily;
- Never permit occupants to sit over the front of your watercraft;

Always operate your watercraft with US Coast Guard approved night-time lighting (red and green forward lights and white light at the rear).

REGISTRATION - In accordance with the LDPOA Property Regulations and Schedule of Fines for our community, all watercraft on Lake Dalecarlia (including those docked in the water or on lifts) must be properly registered with the LDPOA. Failure to register and properly affix registration decals to any such watercraft will result in a \$100.00 fine. Applications are available for any property owner or renter planning to utilize their watercraft at Lake Dalecarlia and can be downloaded from the Community website www.lakedalecarlia.org or picked up from the Information Box located outside the upstairs entrance to the Community building (4665 Main St).

Planning Pier or Shoreline Work – Read This First!

If you are planning shoreline work (seawall, glacial stone, rip-rap, etc.), a new or renovated pier, a waterfront deck or any work at or near the shoreline of your property you may be required to complete a construction application and obtain County and/or US Army Corp of Engineers permits. For details on the specific construction regulations and the approvals required for your project, pick-up a copy of the revised "LDPOA Construction Regulations and Application" from the info box outside of the Community building or download from the Community web-site www.lakedalecarlia.org. Failure to obtain all of the necessary approvals and permits BEFORE commencing work on your project will result in fines from the LDPOA, County and USACE.

ATTENTION Current and Perspective Watercraft Owners

Applications for previously registered watercraft will be sent out via US mail to all property owners who registered a watercraft in the prior year. The application will contain all watercraft and insurance information we have on file. NOTE THE RE-REGISTRATION DUE DATE FOR PREVIOUSLY REGISTERED WATERCRAFT.

Blank applications for new watercraft owners are available and can be obtained:

- By downloading from the Community website www.lakedalecarlia.org From the Information box outside of the Community building

As a reminder to those who may be considering the purchase of a watercraft, the current length restrictions are 24 feet for pontoons and 18 feet for all other motorized watercraft. Horsepower limitations are 90hp for an outboard, 140hp for an IO, 75hp for a two-person personal watercraft and 80hp for a three-person personal watercraft. Horsepower is verified by the LDPOA directly with the manufacturer during the registration process.

ALL motorized and non-motorized watercraft require a current year registration decal in order to be stored or operated on Lake Dalecarlia. VIOLATORS WILL BE FINED \$100.
