LDPOA Membership Meeting Minutes March 2013

The meeting of the Lake Dalecarlia Property Owners Association was held on April 15, 2013. The meeting was called to order at 7:30 p.m. by President Martha Coakley The board members: Mark Torphy, Kelly Steuer, Jim Jacobsen, Tim Hutfilz, Meridith Wells, Tove Roe, Victor Emigh, Jack Hawkins, Laurie Lau, and Don Stone, HH plus 16 general members were in attendance. Kelly amended the March 18th Minutes to reflect that proposals 4, 5, 6 and 7 will NOT be moving forward. On a motion made by Don and seconded by Tim, the Minutes of the March 18, 2013 were approved.

Treasurer's Report The February Treasurer's Report indicated the Total Income was \$10,530, with Total Expenses noted as \$6760.01 with an Ending Balance of \$130,738.90. Mark made a motion to accept February Budget, Tim Seconded, motion carried. The Total Income for the month of March was \$7,657.08, with Total Expenses noted as \$6,760.10 and Ending Balance of \$131,635.97 Victor made a motion to accept March Treasurer's Report and Tove seconded. Motion carried. Out of 566 Assessments, 494 have been paid to date.

General Maintenance: Community Clean Up Day will be held Saturday, April 20th. Ballasts will have to be replaced in some of the ceiling fixtures in the POA Building. Tim will take care of that as well as also looking into options for lighting in front of building. Need to clean gutters, cork board for community use. Flag needs repairing. Merry go round-asking at South Lakeview Drive beach will be removed. We will ask Austgen Construction to remove it during which time they are also completing rehab of the Island.

Lake Dale Trails. At the present time, due to a tremendous amount of rain, we have some swampy areas. This will always be a "work in progress" as seasons change. Two weeks ago Coco arranged to have 450 plants donated from Lowes. They were all planted in one day by Coco, Dennis, Bob, Martha, her daughter and her six year old granddaughter. Everyone felt a huge amount of gratification upon getting them all planted. The goal was to get them in the ground before the rain came...WOW have we ever had the rain! Martha thanked Kathy and Patrick Rompala for working very hard in cleaning up the Island Drive shoreline. Besides clearing the area, Pat also put some reflective signs along the road. In past years this has been very dangerous due to the foliage along the road. The next step is to look

into the POA outlot that runs parallel to the Island Drive entrance. Once again we are reminded of the wonderful volunteerism at Lake Dale.

Island Renovation: Will continue as soon as we can lower the lake again.

Boating Season Report: Obviously boating season will be somewhat held up until the Island renovation is complete. Please either call Carl Elton or Joe Lau. They can also be contacted at Watercraft@Lakedalecarlia.org. Tove reported on the meeting held by the Section Reps. If some sections feel they want some type of Neighborhood Watch signage, please contact Tove. Also the Section Reps want to have another "Meet and Greet" night. More information at a later date.

Request to approach the Board – Dean Dewes, Dewes Excavating Dean Dewes approached the board regarding the storage unit building and the house that is owned by the Michiels family on Mount Street (just south of Main Street). Dean has been working with them to repair their septic field. He stated that at some point in the future they may want to connect to the District's sanitary sewer system. He indicated that in his current repairs, he would like to use a tank that the District uses, so it might lower the future cost of tying in. The board stated that anything that he does up until the point that they are applying for the tap permit, does not concern the District. Nicole stated that if Dean calls the office, she will give him the information regarding the tanks that we order. It was also noted that if the Michiels decide to connect, that the District will have to inspect the tank, as Dewes will be modifying it for the current use. The board stated that just because they purchase the same tank that we use, that it may or may not be acceptable to the District at a later time, depending on the modifications that are made.

Nicole also stated that there are currently 6 open tap approvals available. Dean Dewes thanked the board for their time and consideration.

Planning Pier or Shoreline Work If you are planning shoreline work (seawall, glacial stone, rip-rap, etc.), a new or renovated pier, a waterfront deck or any work at or near the shoreline of your property you may be required to complete a construction application and obtain County and/or US Army Corp of Engineers permits. For details on the specific construction regulations and the approvals required for your project, pick-up a copy of the revised "LDPOA Construction Regulations and Application" from the info box outside of the Community building or download from the Community web-site www.lakedalecarlia.org. Failure to obtain all of the necessary approvals and permits BEFORE commencing work on your project will result in fines from the LDPOA, County and USACE.

Idle Speed Only

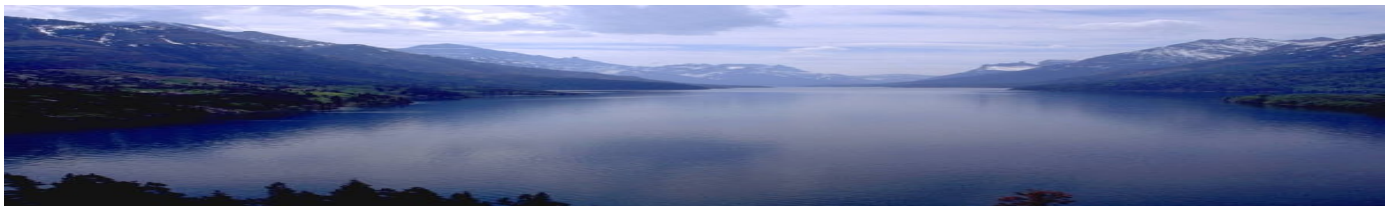
